Lack of awareness of risks	Any number	12		<ul style="list-style-type: none"> -Volunteer guidance notes and risk assessment to be shared with all litter pickers -A safety briefing by the organiser is to be provided to the volunteers before the litter pick event commences -Wherever possible an attendance register should be used for volunteers to record their attendance and confirm they have understood the safety briefing and risk assessment -The organiser should gain permission from the parents/guardian of those under 18 years of age who are to take part -Under 18 year will need to be accompanied by an adult The organiser should decide if the under 18's have the necessary awareness of the risks -Volunteers to conduct a visual inspection & assessment of any potential risks prior to the area being picked 	4		yes
